The World Intellectual Property Organization (WIPO) launched a new service of doing business and other forms of economic activity digitally, that is a proof of existence of a digital file under WIPO proofs. It helps the innovators and creators to safeguard their outputs of many works on the journey from development to commercialization and can be enormously important for research works or for trade secrets or for creative works like music or songs in evolution.

Under Intellectual Property Laws, it is very important that one has a firm and reliable evidentiary support to show that the digital file originated with the person who is purporting to be the owner. Anyone can use WIPO Proof to save any digital file for future evidentiary use. Virtual Hearing @Trademark

The Controller General of Patents, Design and Trademark (CGPDTM) has recently issued a Public Notice on August 26, 2020, wherein the Authority asked Applicant and Authorized Agents to provide consent to attend show cause hearings for their Trademark related matters through Video Conferencing. This is due to increasing rate of Coronavirus cases which compelled the judicial and quasi-judicial authorities to resort to matters through virtual hearings. This was a much-awaited decision as it helps in clearing the backlog of trademark pending matters.

Safety of Toys

Bureau of Indian Standards is a statutory body established under the Bureau of India Standards Act, 2016 (Act). BIS has brought "Safety of Toys" under compulsory BIS certification w.e.f. September 1, 2020 as per Toys (Quality Control) Order, 2020 issued by DPIIT, Ministry of Commerce and Industry. BIS has initiated the process of granting licenses to manufacturers of toys for use of BIS Standard Mark as per Scheme I of Schedule II of the BIS (Conformity Assessment)

Either Aadhaar or Verify

Central Board of Indirect Taxes and customs (CBIC) issued notification vide Notification No. 62/2020, for Applicants want to register under GST. Extension

The Union Ministry of Road Transport and Highways has extended the validity of all motor vehicle documents such as fitness, permits, licenses, registration papers etc. under the provision of Motor Vehicle Act 1988 along with Central Motor vehicle Rules, 1989 till December 31, 2020 vide notification dated August 24, 2020. Now the Ministry has come with its third extension in the past 6 months due to this pandemic situation so that the citizens, the transporters various other organizations which are operating under this difficult time may not get harassed and face difficulties.
